

LIMITED 1-YEAR WARRANTY CERTIFICATE

(Medium and Large UPS Systems – 10KVA to 1200KVA; Asia Market)

General:

The warranties provided by VERTIV Network Power in this STATEMENT of LIMITED WARRANTY apply <u>ONLY</u> to the equipment purchased and <u>ONLY</u> to the purchasers who buy for commercial or industrial use in the ordinary course of each purchaser's business. The term "equipment" means the Liebert product, its features, conversions, upgrades and accessories, or any combination of them.

ONE YEAR LIMITED WARRANTY AGAINST DEFECTS IN MATERIAL AND WORKMANSHIP

Terms of Warranty:

As provided herein, the Liebert product from VERTIV is warranted to be free of defects in material and workmanship for a period of one year from the start-up date, provided that start-up isperformed by VERTIV personnel, occurs within six (6) months of the VERTIV shipping date and the product has been stored in a suitable environment prior to start-up. The start-up date will be determined only from the completed in spection and start-up sheet provided by VERTIV to User. The product shipment date will be determined only from the VERTIV bill of lading. If any part or portion of the Liebert product fails to conform to the Warranty within the Warranty period, VERTIV, at its option, will furnish new or factory remanufactured parts for the repair or replacement of that portion or part.

Warranty Extends to First Purchaser for Use, Non-transferable:

This Warranty is extended to the first person, firm, association or corporation for whom the Liebert product from VERTIV specified herein is originally installed for use (the "User"). This Warranty is not transferable or assignable without the prior written permission of VERTIV.

Assignment of Warranties:

VERTIV assigns to User any warranties which are made by manufacturers and suppliers of components of, or accessories to, the Liebert product and which are assignable, but VERTIV makes NO REPRESENTATIONS as to the effectiveness or extent of such warranties, assumes NO RESPONSIBILITY for any matters which may be warranted by such manufacturers or suppliers and extends no coverage under this Warranty to such components or accessories.

Drawings, Descriptions:

VERTIV warrants for the period and on the terms of the Warranty set forth herein that the Liebert product from VERTIV will conform to the descriptions contained in the certified drawings, if any, applicable thereto, to VERTIV's final invoices, and to applicable Liebert product brochures and manuals current as of the date of product shipment ("Descriptions"). VERTIV does not control the use of any Liebert product. Accordingly, it is understood that the Descriptions are NOT WARRANTIES OF PERFORMANCE and NOT WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE.

Warranty Claims Procedure:

Within a reasonable time, but in no case to exceed thirty (30) days, after User's discovery of a defect, User shall contact the VERTIV provided customer response center hotline and report the problem. Subject to the limitations specified herein, an VERTIV field service representative will repair the non-conforming Liebert product warranted hereunder, without charge for materials, provided VERTIV personnel performed the start-up of the Liebert product. Unless labor warranty option is purchased, user shall be ar all labor or shipping charges associated with repair or replacement of the product herein. Warranty coverage will be extended only after VERTIV's inspection discloses the claimed defect and shows no signs of treatment or use that would void the coverage of this Warranty. All defective products and component parts replaced under this warranty be come the property of VERTIV.

Warranty Performance of Component Manufacturers:

It is VERTIV's practice, consistent with its desire to remedy Warranty defects in the most prompt and effective manner possible, to cooperate with and utilize the services of component manufacturers and their authorized representatives in the performance of work to correct defects in the product components. Accordingly, VERTIV may utilize third parties in the performance of Warranty work, including repair or replacement hereunder, where, in VERTIV's opinion, such work can be performed in less time, with less expense, or in closer proximity to the Liebert product.

Items Not Covered By Warranty:

THIS WARRANTY DOES NOT COVER DAMAGE OR DEFECT CAUSED BY misuse, improper application, wrong or inadequate electrical current or connection, negligence, inappropriate on site operating conditions, repair by non-VERTIV designated personnel, accident in transit, tampering, alterations, a change in location or operating use, exposure to the elements, Acts of God, theft or installation contrary to VERTIV's recommendations or specifications, or in any event if the Liebert serial number has been altered, defaced, or removed.

THIS WARRANTY DOES NOT COVER shipping costs, installation costs, external circuit breaker resetting or maintenance or service items and further, except as may be provided herein, does NOT include labor costs or transportation charges arising from the replacement of the Liebert product or any part thereof or charges to remove or reinstall same at any premises of User.

THIS WARRANTY IS VOID if User allows any battery for the Liebert product to discharge below the minimum battery voltage cutoff point. The warranty is void if the User does not start recharging a discharged, or partially discharged, battery within forty-eight (48) hours of the discharge period.

THE PRODUCTS LISTED IN THIS WARRANTY ARE NOT DESIGNED FOR USE IN THE FOLLOWING APPLICATIONS: (i) ANY NUCLEAR OR RELATED APPLICATIONS; AND (ii) LIFE SUPPORT AND PATIENT-CONNECTED AND APPLIED MEDICAL AND DENTAL APPLICATIONS.

REPAIR OR REPLACEMENT OF A DEFECTIVE PRODUCT OR PART THEREOF DOES NOT EXTEND THE ORIGINAL WARRANTY PERIOD.

Limitations:

- IF USER'S REMEDY IS DEEMED TO FAIL OF ITS ESSENTIAL PURPOSE BY A COURT OF COMPETENT JURISDICTION, VERTIV'S RESPONSIBILITY FOR PROPERTY LOSS OR DAMAGE SHALL NOT EXCEED THE NET PRODUCT PURCHASE PRICE.
- IN NO EVENT SHALL VERTIVASSUMEANY LIABILITY FOR INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES OF ANY KIND WHATSOEVER, INCLUDING WITHOUT LIMITATION LOST PROFITS, BUSINESS INTERRUPTION OR LOSS OF DATA, WHETHER ANY CLAIM IS BASED UPON THEORIES OF CONTRACT, NEGLIGENCE, STRICT LIABILITY, TORT, OR OTHERWISE.

- In the event that any provision of this Warranty should be or becomes invalid and/or unenforceable during the warranty period, the remaining terms and provisions shall continue in full force and effect.
- This Warranty shall be governed by, and construed under, the laws of the State of Ohio, without reference to the conflict of laws principles thereof.
- This Warranty represents the entire agreement between VERTIV and User with respect to the subject matter herein and supersedes all prior or contemporaneous oral or written communications, representations, understandings or agreements relating to this subject.
